



### Policy after 2008-7-14 2008 年 7 月 14 号后国家对外汇的政策

The new foreign currency policy 新的外汇政策法规

1. 外汇管制、外管局、核销单 Exchange Control, <u>State Administration of Foreign</u> <u>Exchange</u>, Verification Form

- 2. 只有具进出口权且拥有结汇额度的公司方可收外汇 Only companies with import & export right and exchange quota can receive the foreign currency and exchange them.
- 3. 部分外资企业有一定的结汇能力,但是额度有限

Some foreign invested companies can receive foreign currency with limited exchange quota.

4. 个人每年 5 万美金限额

Each person is allowed to exchange USD50,000 every year.

# B) 个人贸易者收外汇的方法 THE WAYS OF ACCEPT the foreign currency for SOHO

#### (1) 个人账号 PERSONAL ACCOUNT

特点 character1:

限制:每年限额五万 LIMITATION: USD50,000 /Yei

特点 character2:

#### **REQUIREMENTS:**

如果国外是个人汇个人,没有问题;如果汇款为公司,有些银行需要证明。 PERSON – PERSON, NO PROBLEM COMPANY – PERSON, NEED CERTIFICATE

汇款用途:只能是工资,佣金等,不能为货款
 USAGE OF REMITTANCE: CANNOT BE "CARGO PAYMENT", can ONLY be salary, commission etc.

#### (1) PERSONAL ACCOUNT 个人账号

特点3:需要到银行排队申报结汇

NEED GO TO BANK TO DECLEAR AND EXCHANGE

## (2) 注册具进出口权的公司 REGISTER THE COMPANIES WITH IMPORT & EXPORT LICENCE

#### Character 特点:

- 需要充足的资金 sufficient Money
- 需要专业的知识以及人才
   Professional Skills and knowledge, Talents
- 需要了解国家法律以及相关法规
   Well known China's laws and related regulations.

# (3) 注册香港公司或海外公司 REGISTER THE HONGKONG/OVERSEA COMPANY

- 灵活,没有限制
   Flexible and no limitation
- 有一定的成本,需要到香港开户
   Need a little bit cost For SOHO, need to open an account in HK.
- 离岸银行手续费比较国内高,操作 L/C 等不方便
   Bank charges is higher than inland bank, for overseas account it's not convenient for L/C operation.
- 始终需要结汇 ---- 面临个人账号的问题
   Still the foreign currency need to exchange to RMB.



### If the SOHO register the HK company, How to exchange Usually?




## (4) 地下钱庄/黑市 UNDERGROUND BANK



• 速度快 Quickly

   Low exchange rate, High handling fee
- 违法 Illegal

## (5) 类似支付宝的国际网络支付工具 PAYPAL OR OTHER ONLINE TOOLS

- 1. 方便个人顾客
   convenient for personal customer
- 2. 收费高,速度慢High handling fee, slow
- 3. 结算不灵活 始终要结汇
   Inflexible, Exchange Problem











(6) 西联汇款 WESTERN UNION



- 个人客户,金额较小 Personal Customer, Small Amount
- ⁴ 操作麻烦 inconvenient operation
- 手续费高 high handling fee







- (7) 寻求进出口公司代理收外汇
  SEEK THE ASSIST OF THE IMPORT AND EXPORT COMPANY
  - 方便, 正规 convenient, legal
  - 手续费合理 Reasonable Handling Fee
  - 存在一定风险,需考察
     Risk exist, Need to investigate the company

# SOHO 专有的 B2C2B 和 B2C2C 模式 B2C2B and B2C2C only for SOHO



B2C2B come from B2B

Supplier -> SOHO -> Business (Company)供应商个人贸易者国外客户公司

B2C2C come from B2C

Supplier -> SOHO -> Customer (Person) 供应商 个人贸易者 国外客户个人

SOHO is an Agent!



## 结论 CONCLUSION

• 1. 如果资本充足和专业知识,可以考虑注册正规进出口公司操作

If you have sufficient money and professional skills and knowledge, we suggest you establish an import & export company.

• 2. 如果资本不充足,专业知识缺乏,可以考虑委托正规进出口公司代理

If you are SOHO, w/o sufficient money, professional skills and knowledge, we suggest you SEEK THE ASSIST OF A GOOD IMPORT & EXPORT COMPANY.
